Several questions were asked by Commissioners of the housing authority. The engineer, Mr. Smith showed the board different options they looked at. Engineer suggesting a higher curb up front that would be at least 6" in height. Discussion occurred as to whether Mr. Acevedo can utilize the back of the building. Some board members went outside to look at the property and see if the current chain link fence on his property could be moved over. That would not be an option as it blocks the bay door to the other property. There was no solution that was offered. Later Steve Smith came back in and offered the additional curb in the front so that the limo drivers' could not back up over our lot would be ideal.
